----- Hours of Operation

_____ Private Event Rental

Ben's Apartment charges a rental fee of \$150 per hour to rent the facility. Catering and wait staff is available for an additional charge. Private caterers must be approved by management.

_____ Dress Code

Collared shirts must be worn at all times. Jeans are acceptable but they must not have holes or tears. T-shirts are only allowed on Razorback game days. Hats must be forward faced at all times. Guest will be held to same standards.

_____ Conduct

This is a speakeasy. Please try and keep the volume of your conversations down. Please refrain from yelling or cursing. Profanity will not be tolerated. Treat others how you would like to be treated, including other members and staff. Cell phones must be on vibrate and all calls must be taken in private.

_____ Pictures

No photos of any kind are allowed to be taken in Ben's Apartment. Please do not ask other members for pictures or autographs. Absolutely no tagging members on ANY social media post. Members are solely responsible for their guests and their guests actions.

Guest must remain with member at all times. Guests are not allowed to remain in Ben's Apartment without an accompanying member.

_____ Membership Fees and Monthly Fees
